By signing this application, the applicant is also verifying that the **items to be sold at the market have been grown or created by the vendor.** Vendors and their representatives agree to protect and hold the PHFM, of the City of Dothan, Houston County, their employees, agents, and representatives harmless and to indemnify such entities from any and all claims, demands, suits, actions, judgments, and recoveries, for or on account of any damage, theft, or injury (including death) to property or person occurring as a result of vendor's use of the Market space for which vendor has been approved, including loss or injury resulting to vendor from any cause whatsoever, including but not limited to electrical or equipment failure.
